THIS CONSIGNMENT AGREEMENT IS MADE BETWEEN BOUTIQUE on JAMES AND THE ABOVE CONSIGNOR:

1. ALL ITEMS MUST BE CLEAN, PRESSED, NO STAINS, ALL BUTTONS ON, ZIPPERS WORKING, HEM SECURED, BE CURRENT, FREE FROM ALL ODORS, i.e. SMOKE, ETC., AND NO PET HAIR. THE BOUTIQUE HAS THE RIGHT OF REFUSAL. ANY CLOTHES FOUND NOT SUITABLE FOR SALE MUST BE PICKED UP WITHIN 48 HOURS AFTER NOTIFICATION. IF NOT, THEY WILL THEN BE DONATED. ALL PRICING DONE BY BOUTIQUE on JAMES, EXCEPT: FURS AND LEATHERS.

2. ALL ITEMS WILL BE HELD FOR THREE MONTHS. BEGINNING THE THIRD MONTH, ALL ITEMS WILL BE REDUCED 50% OF THE ORIGINAL PRICE. AT THE END OF THE THIRD MONTH, ALL ITEMS NOT DONATED, MUST BE PICKED UP BY THE 7<sup>TH</sup> OF THE FOURTH MONTH. ALL ITEMS ON THE 8<sup>TH</sup> WILL THEN BECOME PROPERTY OF BOUTIQUE on JAMES. WE ARE THEN RELEASED FROM ALL RESPONSIBILITY.

NO CHECK WILL BE GIVEN IF YOU WALK IN, WITHOUT A PHONE CALL. THE FIRST DATE OF YOUR FIRST CHECK PICK UP IS \_\_\_\_\_. NO CHECKS WILL BE MAILED.
